## Initiatives seek to increase housing supply, lower costs, remove barriers

The Biden-Harris Administration recently announced several initiatives aimed at increasing housing supply, lowering costs and removing barriers to housing construction. One of the key initiatives is the U.S. Department of Housing and Urban Development's (HUD) [Pathways to Removing Obstacles to Housing \(PRO Housing\) grant program](#). This program is designed to support state and local governments in removing barriers to affordable housing, including through reforming the housing permitting process. In June, the first [\\$85 million in PRO Housing grants was awarded to 21 communities](#), and HUD announced on August 13 an additional \$100 million in funding. These funds are being used to accelerate local efforts to reform permitting processes, including expediting approvals, increasing by-right permitting, streamlining environmental reviews and creating clear, objective guidelines for developers. Examples of awarded projects include:

- Expediting the permitting approval process for income-restricting housing projects in Nashville, Tennessee.
- Streamlining permitting requirements for affordable housing in Philadelphia, Pennsylvania.
- Creating regulatory toolkits to improve consistency of housing development and building permits in Rhode Island.
- Expanding staffing capacity to fast-track the review of affordable housing development projects in Denver, Colorado.
- Facilitating adaptive reuse and commercial to residential conversions through an analysis of barriers, code updates and providing best practice templates by New York City, Denver and the Metro Washington Council of Governments.

## Report encourages adopting ICC/MBI Standards 1200 and 1205

The [Humanitarian Supply Chain Lab at the Massachusetts Institute of Technology](#) (MIT) hosted a roundtable in January focused on scaling construction capacity after disasters. The discussion covered key issues such as supply chain management, policy frameworks at various governmental levels, building codes and the complexities of private-sector construction. Attendees included the [Federal Emergency Management Agency](#) (FEMA), the [Department of Housing and Urban Development](#) (HUD), local government officials, emergency managers, the International Code Council, the [National Association of Home Builders](#) (NAHB), modular homebuilders, the [National Institute of Building Sciences](#) (NIBS) and the [Modular Building Institute](#) (MBI). Their participation underscored a growing consensus on the value of off-site construction as a solution for disaster housing and recovery. The [report](#) from the roundtable

captures the essence of these discussions and provides detailed actions and practical recommendations for each stakeholder group, aiming to improve the effectiveness of post-disaster housing solutions.

ElectriCity™ is a new program that recognizes cities for their commitment to electrical safety and provides on-site training from the Independent Alliance of the Electrical Industry (IAEI). By becoming an ElectriCity, the City of Austin, Texas, demonstrates its commitment to ensuring that electrical installations meet required safety standards, reducing the risk of electrical hazards and contributing to the overall safety and sustainability of their community. City staff that participate in the ElectriCity program are better prepared to take the ICC/IAEI certification exams for Residential Electrical Inspectors, Commercial Electrical Inspectors and/or Electrical Plans Examiners. The ICC/IAEI Electrical Inspector Joint Certification Program provides a widely recognized credential that gives certificate holders access to increased job opportunities and improved mobility within the building safety industry.

## ICC Plumbing, Mechanical, and Fuel Gas Updates

### Deadline is September 16 to apply for PMG Code Action Committee

The International Code Council is currently seeking industry stakeholders to volunteer for the Plumbing Mechanical and Fuel Gas Code Action Committee (PMGCAC). Once appointed, these volunteers will take part in identifying areas of the International Codes® (I-Codes) for improvement, introducing new areas of safety for the built environment or clarifying existing I-Codes. These workgroups will have virtual meetings at various times. The meeting days and times will be sent to all interested parties of those work groups. The application deadline is September 16.

### New standard addresses plumbing issues in hospitals, healthcare buildings

The Code Council has proposed to develop a new standard that is intended to provide holistic design, installation, inspection and maintenance requirements for water supply and sanitary drainage systems in hospitals and healthcare buildings with a primary focus on the different risks associated with each area of a hospital or healthcare building. Academic research commissioned by the International Code Council to support the development of ANSI candidate [ICC 815](#) has highlighted the need to consider the sizing of water supply and sanitary drainage piping systems within hospital and healthcare facilities. This and other research have highlighted the heightened risks faced by occupants of these buildings.

### WateReuse Association promotes best practices for recycling systems

The [WateReuse Association](#) is the premier trade association committed exclusively to advancing laws, policies, funding and public acceptance of recycled water across the United States. Supported by its diverse membership—which includes water recycling utilities, businesses dedicated to developing recycled water projects and major industrial and commercial users—WateReuse strives to promote and enhance water recycling in both centralized and onsite systems. Onsite water systems (OWS) are an increasingly attractive complement to centralized systems in more and more communities, reducing pressure on centralized wastewater systems and creating more resilient communities. An OWS captures nearby wastewater, stormwater and other sources to treat and use in a single building or in multiple buildings. There are several groups advancing training programs for onsite reuse. WateReuse, in partnership with NBRC, Austin Water and others, is developing a training program for operators of onsite non-potable reuse systems. The International Code Council is developing a standard for Onsite DPR (ICC 1600 Series-202x, Professional Qualifications Standard for Onsite Direct Potable Water Reuse Systems) to ensure professionals are properly trained and accredited in accordance with industry standards.

## ICC Family of Solutions Updates

### Turn ARPA Funds into office system upgrades by December 31

Recipients of **State and Local Fiscal Recovery Funds (SLFRF)** have two options: **Obligate funds** into contracts by December 31, 2024, **or return the funds** to the U.S. Department of Treasury. Once you obligate funds into a contract, you have until December 31, 2026, to spend the funds. Use ARPA funds to implement a [Laserfiche](#) (records management and process automation) or [Municipity](#) (ePermitting) system, or enhance your existing systems by adding licenses, expanding to more departments, increasing functionality, or getting additional training. There are still **\$89 billion** in ARPA funds that are **unobligated** and **67 percent of recipients have unspent funds**. More than \$57.3 million in ARPA funds have been used for records management and digitization projects, accounting for 219 projects in 40 states. [Download our ARPA Guide](#) to eligible solutions.
