Topic: A moderated Roundtable discussion – Proposed legislative act to allow use of temporary

door locking devices to provide security in the event of a school shooting

Topic Summary

In response to the continued school shootings since 2010, lawmakers are working on legislation to enable emergency door-locking technology in schools. Senator Michael Moore, one of the bill's sponsors, emphasizes the Department of Homeland Security's endorsement of the effectiveness of properly locked doors during active shooter situations and feels Massachusetts should update building and fire codes to allow certain locks in public buildings.

The proposed bill seeks to create new regulations allowing emergency door-locking devices in schools and other public buildings, with local approval processes and consultations with fire and police departments. The bill also requires training for educators and annual inspections of these devices to enhance school safety. The goal is to provide additional security measures in the face of the growing concern over school shootings.

Summary of Legislative Proposal:

The bill, **SB 2514 - An Act to allow temporary door-locking devices in public buildings**, would empower the Executive Office of Public Safety and Security (EOPSS) to establish regulations allowing the use of temporary door locking devices in public buildings, particularly schools. The regulations would cover various aspects, including defining circumstances for their use, determining appropriate locations and consistent operations within buildings, establishing a local approval process involving consultation with fire and law enforcement departments, integrating these devices into safety plans and training, providing in-service training for first responders and public employees, and setting standards for annual inspections to ensure proper usage. These temporary door locking devices are defined as mechanisms that prevent doors from opening, but they must meet specific criteria such as ease of engagement and removal, not modifying existing door hardware, and complying with fire safety standards, with exceptions for buildings equipped with automatic sprinkler systems. The legislation aims to enhance security in public buildings while maintaining safety standards.
