Re: Board Approved Priority Levels/Actions for All Currently Tracked Legislation

As stated in *AIA MA's 2023-2024 Legislative and Regulatory Goals* document, AIA MA and the Government Affairs Committee (GAC) are committed to legislative and regulatory advocacy in the Commonwealth by addressing issues crucial to the architecture profession. Its main policy focus includes environmental concerns like energy efficiency and carbon neutrality, economic justice emphasizing equity in housing and education facilities, coordination and incentives regarding building codes, enhancing the architectural business practice with a focus on diversity and inclusion, and promoting smart growth development policies.

On that basis, the GAC has sought to monitor and support legislative measures aimed at carbon neutrality, zero-net energy buildings, electrification of utilities, restoring provisions from the 2018 Climate Adaptation Management Plan, expanding net-metering, improving coordination within the construction industry, fostering more housing opportunities, especially affordable ones, advancing historic preservation, endorsing the mass timber industry, linking school funding equity with healthy school initiatives, increasing efficiency in state projects, and lastly, opposing legislation proposing a Practice Act for interior designers. All positions on bills prepared by the GAC are consistent with the current Legislative and Regulatory Goals.

Using those metrics, the GAC has identified 153 bills to track and suggest the following priority levels/actions:

- (17) bills be considered a "High" priority;
- (49) bills be considered a "Medium" priority;
- (67) bills be considered a "Low" priority; and
- (20) bills be removed from tracking

We have previously defined "High," "Medium," and "Low" priority bills as follows:

- **High Priority:** These are bills AIA MA has agreed to either support, support with an amendment, or oppose with written testimony. Due to the process of determining AIA MA's position, written testimony may or may not be prepared in time for the bill's public hearing. This will not compromise our ability to advocate our positions with legislative committee staff or leadership. AIA MA will only submit written testimony once it has been reviewed and approved by the Board.
- **Medium Priority:** These are bills AIA MA has agreed to either support, support with amendment, or oppose with written testimony, but only after the legislative committee hearing the bill has determined it intends to move the bill forward in the legislative process. AIA MA will only submit written testimony once it has been reviewed and approved by the Board.
- **Low Priority:** These are bills that AIA MA has agreed to track and decided that, if enacted, would be of potential interest to the membership but have no effect on the actual practice of architecture. If signed into law, AIA MA will inform the membership of a bill's passage.

Lastly, we recommend that (20) bills be removed from the tracking list as they are outside the realm of the practice of architecture.
